Conditions:

1. The school has been registered under the Child Rights Education Act, 2009, and the Karnataka Education Act, 1983 and in accordance with the rules framed thereunder, the accreditation has been renewed up to the registered class. No permission is granted to conduct additional classes or divisions apart from the above mentioned classes and divisions.
2. The School shall function under the rules framed under Karnataka Education Act 1983 and Child Right's Education Act 2009.
3. As per the Child Rights Education Act, 2009, reservation of 25% for the weaker sections of the society shall be made. Government is authorised to enrol seats to RTE for the schools covered by RTE. (Government has made rules to facilitate the enrolment of children in neighbouring schools where their parents live, according to which, if there are government and government-funded educational institutions, children will be enrolled in that school) Otherwise, private schools will enroll children enrolled by the government and allow them to continue their education up to the primary level. To enable these children to continue their education without any discrimination.

4. As explained in Annexure 3, the Government will release the fees of the children enrolled under RTE rules as per the rules and hence stop collecting any fees from these children.

5. The school and the school management are prohibited from collecting any kind of capitation fee and voluntary donations from the parents either at the time of enrolment or later.

6. The school/governing body shall publish the information on the fees charged by the parents of the children as tuition fee in their school as per State Government Notification No: ED:31 :PGC 2019, dated:27 .07 .2019 on departmental website and on the school notice board. No fee shall be charged over and above the prescribed fee.

7. The School/Managing Board shall enroll the students within the period fixed by the Government.

8. The School / Governing Body cannot refuse enrolment against the following points:

- (i) Lack of proof of age
- (ii) based on caste, religion, place of birth, language
- (iii) Application for admission after the extended period of the admission

9. To take all safety measures as per RTE Act and Rules, Karnataka Education Act and Rules [Fire Safety and Building Safety Certificate from concerned authorities and Children's Learning Safety as per K.S.C.P.C.R. and N.C.P.C.R].

10. The school/governing body shall ensure as follows:

- (i) No admitted child shall be retained in any class or expelled from the school till he completes primary and intermediate education in the school.
- (ii) No child shall be subjected to physical or mental abuse.
- (iii) No child shall be required to pass any board examination until the completion of primary education.
- (iv) Every child who completes primary education shall be issued with a certificate as prescribed under RTE Rule No. 21 and the Karnataka Education Act and Rules.
- (v) As per the provisions of the RTE Act and Rules and the Karnataka Education Act and Rules, the school shall also admit children with special needs/special children.
- (vi) Appointed teachers shall possess the minimum qualifications as prescribed for primary and high school teachers in the RTE act and rules and the Karnataka education act and rules and Government orders.
- (vii) Salary and allowances payable to teachers and terms and conditions of service shall be as prescribed by the state government. And salaries are to be paid to teachers through government notification (provident fund (PF)) and payable bank and other salaries and subject to Employee State Insurance (ESI).

(viii) Teachers shall perform the duties prescribed under section 24 (1) of the act and the RTE Act and rules and rule 17 of the Karnataka Education Act and Rules and shall not involve themselves in private tuitions for supervisory considerations.

11. The school shall follow the academic state curriculum and state textbooks to which the school is affiliated.

12. The school shall maintain norms and standards as specified in section 19 of the Karnataka education act. Further as per the prescription in the Karnataka Education Act and Rules, departmental staff shall be appointed.

13. School buildings and other infrastructure related to the school shall not be given for any commercial or political activity or any non-educational activity during day or night.

14. The school shall not be run for the benefit of any person or group or association.

15. The school should be audited by a chartered accountant, and the copy should be submitted to the deputy director/field education officer by the end of June every year.

16. As per the government notification [Kannada Language Policy - 2016] The school shall follow the language policy.

17. Governing body and teachers to act as per RTE Act and Karnataka Education Act and Rules.

18. The school shall follow the rules and directives of the government and the department without fail.

19. Mandatory updating of school information in S.A.T.S. by the end of March every year.

20. In case of violation of the above provisions, the recognition of the school will be cancelled as per the rules framed under the RTE Act 2009 and the Karnataka Education Act 1983.

21. After completion of school accreditation process, complete document/information in the application submitted online by the Governing Body will be made publicly visible by uploading the same on the department's website.

22. Violation of the above conditions will result in the cancellation of the recognition of the school as per the rules framed under the act 2009 and Karnataka education act 1983.
